NestAndCo is a consulting agency founded in 2020 and based in **Valencia, Spain.**

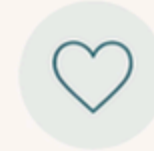
We support Intended parents throughout their surrogacy journey abroad, working with trusted local teams in countries where this practice is regulated by a secure legal framework.

- Possible for: Hetero couples (married or living together)
- Egg donors: Can see photos from a database and non-anonymous
- Birth certificate: both parents
- Passport: Own nationality, no passport awarded



Estimated costs from: **60,000 \$**



COLOMBIA

- Possible for: Hetero couples, same sex couples, singles with a genetic link to their embryos
- Egg donors: Phenotype only, not permitted to show photos
- Birth certificate: both parents or bio dad + surrogate
- Passport: possible to obtain Colombian passport if surrogate is listed on BC or own nationality



Estimated costs from: **61,000 \$**



MEXICO

- Possible for: Hetero couples, same sex couples, singles
- Egg donors: Can see photos from a database
- Birth certificate: both parents or bio dad + surrogate
- Passport: possible to obtain Mexican passport or own nationality



Estimated costs from: **62,000 \$**



USA

- Possible for: Hetero couples (married), same sex male couples, singles
- Egg donors: Open and anonymous options available
- Birth certificate: both parents
- Passport: U.S. passport available for the child



Estimated costs from: **150,000 \$+**
